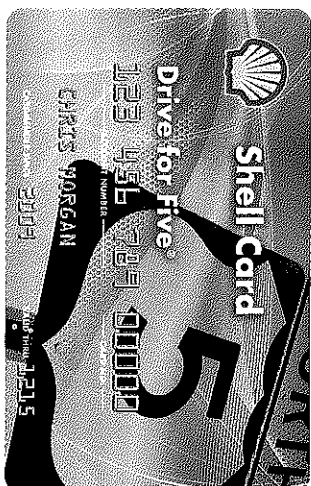

You will receive statement credits based upon fuel purchases made with your Shell Drive for Five Card at Shell locations within the United States. You will earn a credit of five cents (\$.05) per gallon on up to one hundred (100) gallons in each billing cycle that you purchase at least forty-five (45) gallons of Shell fuel. Gallons purchased will be considered for a discount in the billing cycle they are posted to your account. Total annual credit not to exceed \$60.00. Credits will be earned only on fuel purchases made for personal, family or household purposes.

When calculating the amount of the credit, we will multiply the number of gallons purchased by five cents (\$.05) and round to the nearest cent. In the event gallon information is not available for a specific transaction, we will determine the number of gallons purchased by dividing the total purchase amount by an average price per gallon amount obtained from the U.S. Department of Energy.

Credits will be automatically posted to your monthly billing statement. Your account must remain open and current in order for you to earn credits. When you become a cardmember, you will receive the full Shell Drive for Five Program Terms and Conditions, which we may change at any time upon thirty (30) days prior written notice.

If you ask us, we will tell you whether or not we requested a credit bureau report, and the names and addresses of any credit bureaus that provided us with such reports.
- To receive a Shell Drive for Five Card, you must meet our applicable criteria bearing on creditworthiness. Your credit limit will be determined by your annual salary and wages, your other annual income and a review of your debt, including the debt listed on your credit report. Some limits may be as low as \$200. Please note that cash advances may be limited to a portion of your credit amount.
- You authorize us to share with Shell and its affiliates experiential and transactional information regarding your activity with us.
