

Affinity Card terms and conditions

1. In these terms and conditions: Account holder means the applicant in this application. Affinity Card means a Liberty/Shell affinity fuel card issued by Shell to Liberty and in turn issued to the Account holder. Business Day means any day on which banks generally are open in Melbourne, Victoria. Card Products means goods or services purchased with an Affinity Card and Card Fuel Products means petrol, diesel, LPG, ethanol, biodiesel and other fuel purchased with an Affinity Card.

Shell means The Shell Company of Australia Limited (and its permitted assigns).

Shell Card Terms & Conditions means Shell's terms and conditions for Shell fuel cards (the current version of which is in section 7 of this application), as varied or replaced by Shell from time to time, together with any other written terms from Liberty about Affinity Cards.

Shell Online Terms & Conditions means Shell's terms and conditions for its Shell Card website (the current version of which is in section 7), as varied or replaced by Shell from time to time.

2. The Shell Card Terms and Conditions form part of these Affinity Card terms and conditions and apply to purchases of Card Products as varied by these terms and conditions and as if references to "Shell" were references to "Liberty" except

(a) they remain references to Shell in "Shell Card", the definition of "Nominated Premises", "Shell LPG" and its definition, "Shell Oil" and its definition and the first sentence of condition 11 (or equivalent);

(b) they are taken to be references "Liberty or Shell" in the first sentence of condition 6, in condition 12 and in conditions 13(a) to

(d) (or their equivalents)

3. The price for Card Fuel Products is the pump price at the place of delivery at the time of delivery less the discount notified by Liberty from time to time.

4. The Purchaser must:

(a) pay for purchases of Card Products within the time notified by Liberty from time to time and, if no time is notified, within 7 days of delivery;

(b) make payments by direct debit;

(c) if payment is due on a day that is not a Business Day, pay by the immediately preceding Business Day.

(d) ensure that the amount it owes Liberty for Card Products does not at any time exceed the credit limit notified by Liberty from time to time.

5. If the Purchaser fails to make payment or otherwise breaches these terms and conditions, Liberty may exercise its rights under any bank guarantee or other security it holds from the Purchaser or other person on behalf of the Purchaser.

6. Liberty may make the Distributor an authorised user on Liberty's online account with Shell allowing the Distributor to use the Shell card website to manage its Affinity Cards. By using the website, the Distributor accepts the Shell Online Terms and Conditions as if it were the "Customer". Any rights of Shell under the Shell Online Terms and Conditions may be exercised by Shell or Liberty.

7. To the extent of any inconsistency, these Affinity Card terms and conditions prevail over the Shell Card Terms and Conditions.
