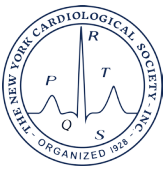

## Program Description

As cardiovascular medicine rapidly evolves, cardiovascular healthcare providers are challenged to determine and recommend the best therapies for their patients. This scientific session provides attendees with the opportunity to examine current topics with the goal of helping them provide the best care for their aging patients. The program will include presentations from nationally respected cardiovascular specialists from around the country. Among the lectures, the topics will center around acute myocardial infarction, non-invasive imaging for diagnosis of cardiac amyloids, telemonitoring, readmission reduction, atrial fibrillation, aortic stenosis, and post-acute cardiovascular care in older adults. Exhibitors will present materials relevant to some of the advances in therapy being discussed. Regular breaks will allow for networking and the ability for fellows in training (FITs) and other cardiovascular clinicians to meet with and to discuss issues relevant to their future and the current practice of cardiology. In addition, the winners of the Young Investigators research competition will display posters of their scientific work, and two clinical case presentations will be briefly presented by the winning fellows of the case competition and discussed by their cardiology mentors.

## Target Audience

The target audience includes cardiologists, cardiothoracic surgeons, internists, family medicine practitioners, gerontologists, oncologists, cardiac nurse practitioners, physician assistants, cardiology fellows-in-training and all members of the cardiac care team.

## Program Objectives

At the completion of this program, physicians and other healthcare professionals in attendance will be able to:

- Explain the rationale for, and identify components of, a comprehensive approach to readmission reduction
- Describe the importance of high-quality, disease-specific care, multiple transitional care interventions, involvement of multidisciplinary teams, and early and frequent outpatient followup
- Navigate the current landscapes of Post-Acute Care and describe its relevance in the care of our geriatric cardiology patients
- Identify gaps in care and specific interventions providers can utilize to improve outcomes
- Identify various types of procedures necessary for treating atrial fibrillation in older adults

## Program Objectives (cont.)

- Explain the rationale for why the management of atrial fibrillation is directed at preventing thromboembolism and controlling heart rate and rhythm
- Identify the effects of aging on CV care and unique aspects of care for older adults
- Delineate the various phenotypes of aortic stenosis in older adults and enumerate mechanisms underlying paradoxically low-flow aortic stenosis
- Identify TTR Cardiac amyloid without a biopsy
- Explain the extent to which current guidelines for cardiovascular disorders are evidence-based with respect to older adults
- Identify strategies for improving care and outcomes for older adults with cardiovascular diseases
- Describe the role of non-invasive imaging for diagnosis of cardiac amyloids
- Recite promising treatments for TTR cardiac amyloidosis
- Describe ways in which telemonitoring can improve heart failure outcomes
- Describe patients' perspectives about the pros and cons of telemonitoring
- Identify management strategies in diagnosing acute MI in elderly patients
