Adobe Swatch Exchange (ASE) files

InDesign, Illustrator and Photoshop all support the exchange of colors via **ASE files**. Load these color files to your program to easily access the Berkeley color palette.

Please use the following color guide:

HEX colors should be used when designing for screens or desktop printing.

CMYK color should be used when designing for 4-color printing (C=cyan, M=magenta, Y=yellow, K=black).

SPOT color is a single color created by Pantone and the most accurate representation of a color when printed.

Adobe COlor (ACO) files. A file with the ACO file extension is an Adobe Color file, created in Adobe Photoshop, that stores a collection of colors in HEX, RGB and CMYK color spaces.
