Your proof should be used to check:

- ✓ For spelling mistakes and missing digits
- ✓ That you have included all the details you want (email, URL etc)
- ✓ If your design reaches all the way to the edge of the bleed
- The orientation of your design. If you fold this page in half would your designs face the right way up?

Your proof can't help with:

Color proofing – what you see on your screen will always look slightly brighter than the printed version. Similarly, your printer may not print exactly the same as ours.

Please note: This proof is designed to allow you to check your designs and to proofread (we know it's often easier on paper). It is not a full print-ready file. Any images on this preview are high-resolution but are not our full print resolution.
